I further assume full responsibility for the safety and insurance of my exhibit, for all sales tax occasioned by its use, and for picking up any and all trash in the area assigned to me. The Harbor Festival reserves the right to reject any application to maintain consistency within the Festival venue.

I further understand and agree to the following rules:

- To conspicuously display a copy of my seller's permit at my exhibit space.**
(If I am not offering for sale anything that is subject to sales tax, I will provide the Festival with a written statement to that effect, along with a copy of my Driver's License.)
- To only exhibit products or services suitable for a family-oriented event.**
- To not exceed my assigned space size, as assigned by the MBHF.**
- To not infringe on walkways, neighboring booth spaces, or move to another location without official permission.**
- I have read the attached Exhibitor Information and agree to follow the rules therein.**

I also understand that refunds will not be granted after September 1, 2018 and that entry fees are nontransferable without written MBHF authorization. I certify that the information on my application is true and correct, and that I understand all other rules and regulation herein, and understand and agree to abide by them.
